The Regular Meeting of the San Bernardino International Airport Authority was called to order by Councilmember Ovidiu Popescu at approximately 3:07 p.m. on Wednesday, February 27, 2019 in the Main Auditorium of the Norton Regional Event Center, 1601 East Third Street, San Bernardino, California.
